

PARENT/GUARDIAN PERMISSION FORM

By doing business with one or more of Maggard's Companies, this release covers all companies: Akers Ferry Canoe Rental, Jason Place Campground, Round Spring Canoe Rental, Wild River Canoe Rental, Maggard Canoe & Boat, and Jacks Fork Canoe Rental and Campground.

I hereby grant permission for my child _____ to participate in canoeing, kayaking, swimming, and camping at MAGGARD'S COMPANIES on (date) _____.

I fully understand and acknowledge that: (a) risks and dangers exist in my child's use of canoeing, kayaking, swimming, and camping equipment and my child's participation in canoeing, kayaking, swimming, and camping activities (b) my child's participation in such activities and/or use of such equipment may result in injury or illness or death or damage to personal property (c) these risks and dangers may be caused by other participants, or by accidents, or by the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, selection of trail or river route, water level, weather conditions, risk of falling out of a kayak, canoe, tube, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment; and (d) I hereby accept and assume these risks and dangers.

I have been advised that my child must wear an approved personal flotation device at all times while on the water. I affirm that my child will not be under the influence of alcohol or controlled substance, and will not carry, use, or consume these substances before or during her/his scheduled activities. Any claims or disputes arising from my child's participation in MAGGARD'S COMPANIES equipment shall be venued in the Shannon County Supreme court of the State of Missouri.

My child is in good health and is at or above the minimum age stated in Maggard's Companies advertising for each activity in which he/she will participate. I understand that strenuous physical exertion may be required and my child has no known physical disabilities or health problems, which will present any risk to his/her participation in the activities. I release and agree to indemnify and hold harmless the Releasees from any and all liabilities to my minor child's involvement or participation in these programs as provided above, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, to the fullest extent permitted by law. I permit the use of any photos, slides, films, or sketches of him/her taken during the day's activities for publicity, advertisement, promotion or other commercial purposes. The above agreement shall be binding on my heirs, successors, assigns, administrators, and executors.

I HAVE READ THE ABOVE AND BY SIGNING IT AGREE. IT IS MY INTENTION TO GRANT PERMISSION FOR MY CHILD TO PARTICIPATE IN MAGGARD'S CANOEING, KAYAKING, TUBING, AND CAMPING ACTIVITIES AND TO ASSUME ALL RISKS ASSOCIATED THEREWITH.
